<b>Subject objectives</b>	The classes are similar in nature to a translation course: students work on a larger whole text (work) or on smaller excerpts that illustrate some literary, cultural or historical issue; thus, on the one hand, they consolidate, expand and systematize lexical-grammatical knowledge and improve their skills in translating from Latin into Polish, and on the other hand, they learn to pose and solve research problems (of course, with a low degree of difficulty and small scope).
