Subject contents	The course programme is a chronological continuation of the topics covered in the first semester and covers contemporary methods in art history (from the late 20th century to the present day) within the broader context of cultural history. Particular emphasis will be placed on discussing the development of feminist research in the visual arts and on the influence of the most significant trends in contemporary humanities on art research (including the narratological turn, the turn to things, the performative turn, oral history and the trend of social archiving). An important issue addressed in the course will be the reception of new methodological trends by Polish art history (including Piotr Piotrowski and horizontal art history, and the essayistic work of Maria Poprzęcka). Issues concerning contemporary methodological approaches present in both international and Polish discourse will be discussed within a broad interdisciplinary context, in a raisonne format, based on the analysis of selected theoretical texts.
