Subject contents	The student encounters religions not only in theoretical but also practical terms. They have the opportunity to visit a place of worship, learn about its peculiarities, traditions and everyday functioning. This is a rare opportunity to travel from 1444 to 1574 in a week and consider which of the Greek Catholic or Polish Catholic denominations is closer to the Roman Catholic one. It is an opportunity to visit Protestant and Orthodox religions, talk to an imam and a rabbi. It is also an opportunity to meditate with Buddhists and think about the difference between religiosity and spirituality. This is a rare opportunity to discuss with Mormon missionaries and consider the difference between a church and a sect. Ultimately, it is about finding doctrinal and ritual differences in Protestant denominations and an attempt to verify the so-called New Age, neo-pagan and neo-Slavic cults in terms of their possible religious functions.
