Subject contents	German studies as a field of humanities research. The concepts of 'culture' and 'cultural text'. The literary text as a cultural text. Hermeneutics as a science of textual understanding. Text as an object of interpretation and over-interpretation. Elements of the (literary) text relevant to the process of analysis and interpretation. New literary forms: literature and new media. Literary narrative in cultural discourse. Elements of narratology. Contexts of interpretation and selected research concepts (structuralism/poststructuralism, historicism, gender studies, intertextualism, semiotics, deconstruction, postcolonialism) . Cultural borderlands as a theoretical issue (basic borderland and border concepts, the concept of "old" and "new" borderlands, centre-periphery relations) . The issue of cultural diversity (cultural heritage, post-modern multiculturalism, cultural pluralism, melting pot). Clashes and interpenetration of cultures (accommodation, assimilation, segregation, antagonism, "borderland experience"). Images of self, other/alien, stereotypes. Identity in the borderland (cultural competence, enculturation, acculturation).
