Formal and Substantive Guidelines for Writing a Bachelors Thesis

- Structure of the thesis: introduction, theoretical part, research part, conclusions and recommendations.
- Principles of writing: logical coherence, linguistic correctness, citation of sources.
- Selection of the thesis topic in the context of current constitutional, administrative, and public issues.
- Formulating the research problem, research questions, and hypotheses.
- Academic style and scientific standards applicable at the Faculty of Law and Administration, University of Gdańsk.
- Requirements regarding formatting, bibliography, and footnotes according to university and faculty regulations.

Principles of Collecting Materials for Research

- Identification of sources: academic literature, legal acts, case law, official publications.
- Techniques for collecting empirical data: interviews, surveys, observations, document analysis.
- Evaluation of the reliability and relevance of information sources.
- Organization of collected materials to enable their effective use in the thesis.
- Ethical and legal aspects of using sources and conducting research (personal data protection, copyright).
- Creating a database of bibliographic and source materials for the research.

Research Methodology in Administration

- Basic research methods applied in public administration.
- Selection of research methods appropriate to the research problem (quantitative and qualitative methods).
- Data analysis and interpretation of results in the context of administrative issues.

Writing and Presenting Results

- Methods of presenting research results in written and oral form.
- Preparation of the thesis outline, plan, and drafts.
- Guidelines for preparing the thesis defense: oral presentation, defending hypotheses, answering questions.

Integration of Theoretical Knowledge with Administrative Practice

- Using practical experiences and case studies in developing the bachelors thesis topic.
