Security and enforcement in business transactions. 5. Appeal proceedings in civil cases. 6. Forms of conducting business activity. 7. Principles of undertaking and conducting business activity. Free, licensed and regulated activity. 8. Construction of a contract in business transactions - elements, parties, selected contractual clauses. 9. Consumer rights. 10. Basics of family law. 11. Industrial property law. 12. Intellectual property law, including the law of new technologies. Competition law. 13. Legal aspects of e-marketing and advertising.
