To make students aware of the necessity to continuously improve their linguistic and translation skills, as well as to develop soft and social competences indispensable in interpreting. To develop the ability to search, select and analyse information needed for interpreting. To raise awareness of the importance of ethics and the role of responsibility in the profession of a sworn interpreter.

		The student: 1. Has knowledge of the legal status, obtaining professional qualifications, requirements for candidates for translators in terms of education, knowledge and skills, as well as the organisational specificity and practical aspects of the work of sworn translators in Poland. 2. He/she is familiar with the basic ethical principles applicable to sworn translators in Poland and is aware of the legal and professional liability of translators for non-compliance with their duties and breaches of professional rules. 3. He/she is able to acquire knowledge on the issues covered in the lecture on his/her own, being aware of the fact that acquiring knowledge and gaining translation experience is conditioned by the specific nature of the profession of a sworn translator, who by virtue of the law is obliged to constantly improve his/her professional qualifications. 4. He/she is aware of the fact that a sworn translator who, by virtue of the law, produces certified translations of documents and certified interpreting is obliged to observe standards of professional ethics and to carry out the tasks entrusted to him with particular care and impartiality in accordance with the rules laid down by law. 5. He/she is ready to meet the challenges facing the sworn translator as a person of public trust; recognises and correctly identifies problems related to the provision of certified translation in Poland and seeks the best solutions in this respect. Subject contents	Sworn translators in Poland: historical background, number of translators, legal regulations of the profession. Certified translation and interpreting: specifics of the work, place, requirements, rules, rates. Practical side of the translation activity and organisation of sworn translators' work: organisational aspects, subordination and control, clients and recipients of translation services, opportunities and threats in professional development, employment prospects (work vs. cooperation). Resources and equipment: stamp and repertory of a sworn translator, translator's library, materials and databases, hardware and software. Skills and aptitudes necessary for the profession of a sworn translator: factual and linguistic preparation, gaining translation experience, ability to search and select information, importance and use of soft skills. Ethics and responsibility in the profession of a sworn translator as a person of public trust: is it worth it (a job or a vocation?), a translator as an expert witness, security issues, advantages and disadvantages, and the extent of responsibility incurred. The lecture is conducted with the use of a multimedia presentation, supplemented by numerous interesting facts from the practice of the profession of a sworn translator. The presenter presents the topic based on her knowledge and almost 30 years of experience as a sworn translator.
