Subject objectives	The aim of the course is to develop in-depth and critical knowledge of global economic processes and their social and environmental consequences. The course enables students to understand the mechanisms that sustain and deepen economic inequalities between developed countries and the Global South, the limitations of economic growth in developing economies, and the impacts of climate change, which most severely affect disadvantaged and excluded communities. The course fosters the ability to analyse how tax policy, consumption models, value chains, and international economic regulations influence the dynamics of social exclusion, migration, and environmental degradation. Students will explore the Sustainable Development Goals (SDGs) from an economic perspective, acquire skills to assess alternative development indicators, including the concept of degrowth, and reflect on social responsibility and the ethical dimension of managerial decisions. The course prepares future leaders to design policies and economic strategies oriented towards inclusive and equitable development that goes beyond the traditional understanding of growth measured solely by GDP.

		The student identifies the causes and consequences of global economic and social transformations, including the effects of climate change, migration, and the development of international value chains. The student knows the basic norms and ethical principles related to corporate social responsibility, poverty reduction, and preventing social exclusion in the context of the global economy. The student is able to analyse the impact of globalization, climate change, and social inequalities on the economic situation of developing countries and to interpret migration processes within the global economic context. The student can identify and compare different public policy strategies aimed at reducing poverty and social exclusion, evaluating their effectiveness and side effects. The student is able to take into account environmental, social, and ethical aspects when analysing economic projects and to assess their impact on sustainable development and the implementation of the Sustainable Development Goals (SDGs). Example issues/ example questions/ tasks being completed	Analysis of convergence criteria according to the Solow model and divergence mechanisms identified by Rodrik, including assessment of the effectiveness of cohesion policies in reducing development disparities based on empirical data and drawing conclusions on the impact of public interventions. Evaluation of the development potential of European countries based on ESPON reports, with a detailed analysis of the growth dynamics of countries that joined the European Union after 2000, and understanding the relationship between EU support and structural economic transformation. Examination of the structure of global value chains and identification of mechanisms for transferring environmental and social costs to developing countries, including calculating the actual carbon footprint of products consumed in developed economies and interpreting the results. Historical analysis of greenhouse gas emissions by main sectors and regions, identification of the causes of emission increases in historical and contemporary perspectives, and critical assessment of the effectiveness, costs, and achieved outcomes of mitigation efforts. Analysis of the causes of economic and climate migration and understanding of the mechanisms by which migration affects demographic structures, labor markets, and welfare systems in both origin and destination countries, based on statistical data and migration models. Assessment of the implementation of the Sustainable Development Goals (SDGs) in economic and social dimensions, analysis of actual progress and discrepancies between declared objectives and achieved results, and drawing conclusions on the effectiveness of related policies. Analysis of the tax systems of selected countries, identification of mechanisms through which progressive taxation operates, its impact on income redistribution and inequality reduction, along with evaluation of budget revenues and the tax wedge, and conclusions on the effectiveness of these instruments. Evaluation of the impacts of development projects implemented by international organizations, analysis of their effectiveness in reducing poverty and social exclusion, and identification of success and failure factors in project implementation. Critical analysis of the concept of degrowth and alternative models of economic development, identification of arguments for and against their application, and assessment of the feasibility of implementing such approaches in national policies. Understanding the mechanisms of corporate social responsibility and ethical leadership in the context of globalization and climate change, and analysis of the relationships between business strategy and the reduction of negative effects of economic development.
