Example issues/ example questions/ tasks being completed	In the form of a report, in small groups, students describe a given community and the action taken in a given community. They use the knowledge and experience gained while working with the community and perform desk research. The report should include: characteristics of the place and local community; characteristics of people/groups/organizations/institutions, with whom the group carries out the activity; justification for the choice of location and action; your role as a researcher and activist, as well as relationships and contact with local actors; description of the activity (form, topic, time and duration, place, stages of the activity, recipients/participants, non-participants, opinions on the activity, behavior, method of communication and other important issues according to the authors); performance problems and proposals to overcome them; what this experience gave the authors. Skillful reference to the literature on this subject and other publications in the field of social sciences relating to local communities/localities will also be assessed.
