Reflect on their own positionality and cultural assumptions in relation to the texts and theories studied. Formulate and support original arguments in written and oral formats that incorporate both theoretical and textual analysis. Apply theoretical perspectives to broader social, political, and global contexts, understanding how literature and culture participate in shaping and challenging identity categories.
