Principles of permitted use of protected works, including the identification of the creator and source. Specificity of protection of rights to audiovisual works and computer programs. Protection of the right to image and permission to use it. The right of quotation. Protection of copyright in press activities. Organizations for collective management of copyright or related rights. Principles of the Copyright Commission, including dispute resolution and the right to court. Principles of operation of the Fund for Promotion of Creativity. Principles of criminal liability for infringement of copyright and related rights. Protection of copyright and related rights on the Internet.
