Subject contents	Factors shaping the contemporary Polish language. Selected phenomena of official and unofficial Polish (at the discretion of the Instructor): orthographic problems (e.g. tendency to overuse capital letters and separate spelling, changes in regulations); punctuation phenomena (e.g. differences between spelling regulations and practice); phonetic phenomena (e.g. changes in pronunciation, changes in accent); word formation phenomena (e.g. feminine names derived from names of professions, functions and academic titles, new compound words, unilaterally motivated compounds and quasi-compounds, new types of word formation); inflectional phenomena (e.g. spreading tendency towards indeclinability of proper names); syntactic phenomena (e.g. nominalization and analysis of official syntax, modalization of sentences); lexical and phraseological phenomena (e.g. new borrowings against the background of the history of borrowings in Polish, sources of new phraseologisms); axiological changes and changes in the awareness of speakers.
