Subject contents	1. presenting the subject of research on contrastive, normative, descriptive, historical, confrontational and contrastive grammar, with particular emphasis on translational grammar; 2. theoretical foundations of contrasting the grammatical systems of Italian and Polish, explanation of concepts such as: equivalence, linguistic isomorphism, congruence, transfer, interference, false friends (falsi amici), translation studies; 3. differences and similarities between Italian and Polish grammatical terminology and grammatical categories; 4. the most important differences between the phonetic systems of both languages: pronunciation of "typically" Polish and "typically" Italian sounds, homonymy and polysemy; 5. parts of speech in Polish and Italian; 6. nominal group in Polish and Italian: functions of the article and selection of appropriate structures in Polish, determiners, order of elements in the noun group, noun, adjective, numeral, pronoun, 7. Polish declension and Italian prepositional phrases - analysis and translation of individual constructions; 8. verb group: aspect of the verb and ways of expressing it in Polish and Italian, active and passive voice, si passivante and si impersonale construction and possible translations into Polish, Polish and Italian modes and tenses; 9. syntax: order of a single sentence, structure of complex sentences; 10. word formation: derivation, alternations; grammatical analysis of the source text for translation
