Subject contents	The specifics of communication in the family - the importance of 'Face to Face' communication in the development of family ties (synergistic communication, building higher-order communication, the issue of carnality and sexuality in mutual relations, etc). Ways of effective negotiation in the family (e.g., in the context of fulfilled social roles, division of responsibilities, etc.). Recognizing 'one's own contribution' to the family, recognizing the needs of oneself, one's partner and other family members, the importance of feedback in mutual interaction, etc. Recognizing the various forms of exclusion practiced in the family. Resolving conflicts in the family and the developmental characteristics of conflict. Distinguishing conflict from manipulation and other aggressive, violent strategies used in the family (in the context of known violent strategies, e.g., Karpman's theory). Exclusionary practices in the family and how to deal with them through effective mutual communication (full expression of communication, 'I' messages, effective listening strategies, assertive enforcement of one's rights and expression of one's wishes, assertive refusal, converting evaluation into opinion, dealing with criticism and distinguishing its varieties, etc.).
