Subject contents	<p>Lecture: a synthetic discussion of the development of German art from the early Middle Ages to the XX century in chronological order, taking into account the originality of German art, its iconography in the field of sacred art, the development of graphics, the sound of Protestant and Catholic art, and the expansion directed towards Eastern Europe.</p> <p>Introduction to the history of art in the German language area by eras, based on selected examples from architecture, painting and sculpture; Art in the Germanic provinces of the Roman Empire (Trewir, Cologne, Mainz; limes); Carolinian art (Imperial palaces in Aachen and Ingelheim, Lorsch, Steinbach) and book painting; Romanesque style (imperial cathedrals (Spira, Maintia, Wormacy, Bamberg), imperial palaces, Benedictine and Cistercian monasteries, Romanesque churches in Cologne); Gothic style (Marburg/St. Elizabeth, Cologne Cathedral with equipment, Naumburg Cathedral, castle architecture, urban architecture, brick architecture of the Baltic coast, sculptures (Riemenschneider, Wit Swosz), board painting and Dutch influences; Renaissance painting and graphics (Albrecht Dürer, Lucas Cranach, Holbein, Hans, Aldegrevier, Hans Baldung and Grien); Baroque (residence in Würzburg, castle in Berlin, church Vierzehnheilige); nineteenth century (classicist and historical architecture: Friedrich Gilly, Karl Friedrich Schinkel, August Stüler, Gottfried Semper; the beginnings of the protection of monuments (Ferdinand von Quast); Louis II castles in Bavaria; Schwerin castle; Caspar David Friedrich painting); Twentieth Century (Bauhaus; Erich Mendelsohn; Expressionism).</p>
