Subject contents	Pragmatics as a scientific discipline, history of pragmlinguistic thought, place of other linguistic disciplines; basic components of a communicative situation; model of a communicative act and functions of language as seen by various linguists, e.g. Bühler, Jakobson; Systemic meaning vs. pragmatic meaning of an utterance; speech act theory - its creators and main assumptions (Ch.Peirce, J. Searle); three aspects of speech acts: locution, illocution, perlocution. Conditions for a successful speech act; taxonomy of speech acts by K. Wagner and G. Harras; comments on terminological confusion in the classification of speech acts; linguistic exponents of illocution, performative verbs. Direct and indirect speech acts; deictic indicatives of verbal utterances; the role of context in the determination of the type of illocution; Grice's conversational rules and how to violate them. Conversational implicatures; analysis of exemplary speech acts using the terminology learnt; at the student's choice: analysis of selected text types in terms of speech act type; critical summary of pragmlinguistic theories.
