Subject contents	Islam is a comprehensive and multi-faceted reality. At this stage of study, basic knowledge about Islam will be discussed, of a historical, doctrinal-ethical and socio-political nature. The conditions and mechanisms that in the past led to the emergence and development of Islam as well as those elements that currently influence the spread of Muslim civilization will also be indicated. The historical part will discuss the religious and social situation of pre-Islamic Arabia, the role and importance of Muhammad and individual stages of the formation of the Muslim world. The subject of the second part will be the sources of Islam, i.e. the Koran and Sunna, and the Muslim law developed on their basis. The third part will be devoted to doctrinal issues and moral principles. In the context of the truths of faith, the cult and religious duties of a Muslim will be presented. The subject of the next part will be selected elements of the structure of Islamic society and the most important stages of a Muslim's life. The sixth part of the classes will be devoted to the political dimension of Islam, with particular emphasis on fundamentalism and issues such as democracy, tolerance and human rights. The last part will discuss European Islam and Islam in Poland.
