During the course, students will become familiar with the major theories explaining the causes of criminal behavior, the mechanisms leading to the commission of crimes, and their consequences for offenders, victims, and society. The course develops students' ability to critically analyze crime-related phenomena, evaluate information presented in the media, and understand the role of the state and society in crime prevention. It also aims to foster awareness of the consequences of crime and the importance of crime prevention, victim protection, and shared responsibility for public safety.

Victims of crime and the phenomenon of victimization. The social, economic, and legal consequences of crime for individuals and society. The functioning of the criminal justice system and the role of law enforcement agencies. Crime prevention, including preventive measures, offender rehabilitation, and social reintegration. Analysis of real-life cases and discussion of contemporary issues related to crime.
