The development of AI and literature: potential and risks. Hermeneutics as a science of text comprehension. Text as an object of interpretation and over-interpretation. Elements of a literary text that are relevant in the process of analysis and interpretation of a literary work. Types and genres of literature. Elements of narratology: narrator, perspectives and categories of narration. Time and space in epic texts. Contexts of interpretation. Selected schools, concepts and methods of literary studies. Literary workshop: preparation of a bibliography and footnotes.
